CANCELLATION OF LESSONS BY STUDENT

The Student may cancel tuition by giving **at least** twenty-four (24) hours' notice prior to the Tutor in which case no tuition fee will be incurred. Lessons not attended by the Student without giving twenty-four hours prior notice to the Tutor shall be charged at the full rate.

CANCELLATION OF LESSONS BY TUTOR

The Tutor may cancel lessons by giving twenty-four (24) hours prior notice to the Student in which case no fee shall be incurred. Where a lesson was pre-paid, the Tutor shall reschedule the appointment at a time agreeable to both parties, failing which the Student's account will be credited with such a missed lesson fee.

LATE ARRIVAL

Fees are calculated according to the times stipulated in the schedule and no adjustment shall be made for lost time because of late arrival by the Student.

OBLIGATIONS OF THE TUTOR

- a. The Tutor undertakes to do all preparation prior to lessons and to structure lessons in such a way as to optimize time to the benefit of the Student.
- b. The Tutor shall keep confidential all information of the Student and shall contact other parties involved in the education of the Student only if given written permission by the Student to do so, unless said Student is a legal minor.

TERMINATION
